## TOURISM DEVELOPMENT PLAN Iconic Cross Restored to Glory for Downpatrick

This project was launched in November 2013 with the aim of preserving the 1100 year old High Cross of Downpatrick by relocating it to a purpose-built extension, to be constructed to the rear of Down County Museum. Down District Council has worked closely with the Church of Ireland, the Northern Ireland Environment Agency and the East Border Region to facilitate the project by means of a grant of £486,000 from the EBR Tourism Development Plan.

In April the original cross was restored to take centre stage in a new specially constructed Christian Heritage gallery within the Down County Museum in Downpatrick.

#### **TRANSNATIONAL & INTER-REGIONAL PROGRAMMES**

EBR have recently submitted applications to the ERASMUS+, North West Europe, COSME and Horizon 2020 programmes. In addition two project proposals are currently being developed by the EBR Energy Steering Group for submission to the Northern Periphery & Artic (NPA) programme over the coming weeks. The EBR Biodiversity Steering Group are developing a Green Infrastructure proposal for submission to the EU LIFE Programme. In the field of Tourism the Geo Tourism and Tourism Development Plan steering groups are developing separate proposals project for submission to the Atlantic Area Programme when it opens for applications later in the year and the EBR Economic Development sub committee are in the early development stages of a number of potential projects.

The STEM project has assisted over 150 cross border businesses save in excess of £1 million through networking, identifying savings and enhancing their environmental performance.

### PLATO EBR LAUNCHES REPORT ON SUSTAINING COLLABORATIVE NETWORKS FOR THE SMALL BUSINESS SECTOR



Over 150 Micro-enterprises and SMEs across the East Border Region were welcomed to the PLATO EBR Sustain 2015 event in Carrickmacross to mark the success and closure of the PLATO EBR project. The Sustain event drew together businesses from diverse industry sectors participating on the 2-year PLATO EBR Programme. The Plato Model is underpinned by 'Parent companies' who are larger SMEs or multinationals in the region who provide senior executives to the

Programme with significant levels of expertise in specialist functional areas. Two senior executives from two different Parents, act as Group Leaders for a group of 10-15 growth-oriented small businesses that meet every month. The PLATO EBR Programme hosted 13 Groups and an additional 2 graduate or advanced Fora and 3 clusters in the area of export, food and tourism. The Programme therefore supported over 200 companies across the East Border Region. At the Sustain event, much of the discussion focussed on the value of sustaining collaborative networks in challenging growth conditions where PLATO EBR launched an official report into their findings throughout the Programme. The audience heard from a range of Parent and participant companies, they included Brian McConville MJM Group who talked about ways to sustain the entrepreneur through global growth. Brian started his company with

one and in 2013 the company celebrated 30 years in business and celebrated with the official opening of its custom built 100,000ft2 manufacturing facility in Newry, Northern Ireland. Since moving to the new facility, MJM's turnover has grown from £11.7m to £30m. Brian may operate a multi-million pound international company which takes him to far flung places of the world, but he returns to his native Banbridge to facilitate the PLATO EBR Group.

Dr Cecilia Hegarty Director of PLATO EBR, who presented some of the key findings from the PLATO EBR Report, "Sustaining Collaborative Networks" took the opportunity to highlight some of the soft impacts of the Programme and indicated the evidence showed already some initial key financial improvements in the participating companies as a result of their involvement in the PLATO EBR cluster.

## **SMART ECO HUB SUSTAINABLE BUILDING GUIDE LAUNCHED IN STORMONT BELFAST**



On 14th April 2015 the Smart ECO Hub Sustainable Building Guide was officially launched by Minister Mark H Durkan in the prestigious Parliament Buildings Stormont in Belfast. The event was attended by representatives from local government and the private sector.

Speaking at the launch, which saw representatives from local businesses, local government and the construction industry, North and South, Minister Durkan said: "I very much support the use of sustainable renewable technologies in new buildings. We have geared planning policy to help integrate renewable energy technology into the design, siting and layout of existing and new buildings.

"This Guide demonstrates another good example of the benefits of collaboration between local authorities and the private

sector. It has produced a practical document that can be applied in the planning and adaption of buildings in the North and South

"It is important that we continue to work together and share our experiences as well as exchange ideas that will support our wider understanding of issues that affect our environment

The Smart ECO Hub initiative has demonstrated the benefits of collaborations between local authorities. Over the last 3 years the Smart ECO Hub has grown the energy cluster to include over 100 member companies. It is very encouraging to see that some of the members have been successful in obtaining funding to support product development and this highlights the innovation capabilities in the region. Without this regional cluster initiative these opportunities would have been unlikely to develop and consequently the region and the respective counties are better as a result. The Smart Eco Hub project completed at the end of May however the project steering committee have committed to continue to meet to explore opportunities for developing the legacy of the project further.

view on the meaning of innovation and the impact it can have on a business. Susan was impressed with the results the iOTA Programme had achieved and wished all participants every success for the future. Out of 350 businesses assisted 72 developed new products, 49 entered new markets, 58 participants created a new business, 29 new jobs were created and 177 jobs sustained. With results like these it is evident that the positive effects of the iOTA Programme will be felt throughout the region for many years to come.



## NEW FOOTPATH AT THE HILL OF SLANE
